I understand that skiing in its various forms, including snowboarding, involves risks, dangers, and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, bare spots, rocks, stumps, debris, fences, posts, trees, lift equipment and towers, surface lifts, light poles, signs, buildings, roads and walkways, ramps, table tops and other jumps, including the angle of their approaches and the angle and length of their take-off ramps and landing areas, rails, boxes, tube jams, and all other terrain features, padded and non-padded obstacles, grooming equipment, snowmobiles, and collisions with other persons and other natural and man-made hazards. I acknowledge that the risks in the sport of skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility code (known as Your Responsibility Code), and using common sense.

THE UNDERSIGNED agrees that ANY CLAIM for injury and/or death against Granite Peak Corporation, its owners, officers, shareholders, agents, and employees shall be governed by the laws of the State of Wisconsin and exclusive jurisdiction of any claim shall be the Circuit Court for Marathon County.
